I/we further agree to not declaw this/these pet(s) and to return the pet(s) to VSA in the event that I/we, for whatever reason, can no longer care for the pet(s) and/or keep the pet(s) in my/our personal possession, excluding short periods of time during which proper care has been arranged for with others. I/we also agree that any transfer of ownership of the pet(s) to another person requires VSA's prior consent. Upon violation of this agreement, ownership of this/these pet(s) reverts to VSA. It is understood that all adoption fees are not refundable, including prepaid adoption fees unless VSA determines the pets is/are not adoptable because of disposition or health conditions or otherwise fails to deliver the agreed-upon pet(s), excluding reasonable delays for medical reasons.
